

INFORMATION CONCERNING THE USE OF THE RIGHT TO WITHDRAW FROM THE CONTRACT
Applies to the Consumer, i.e. a natural person who has purchased goods for a non-business purpose.

The right to withdraw from the contract.

You have the right to withdraw from this contract within 14 days without giving any reason. The deadline to withdraw from the contract expires after 14 days from the day they entered. You in possession of things or in which a third party other than the carrier and indicated by you came into possession of the things. To exercise the right of withdrawal, You should inform us (eshop@aggi.pl) about your decision to withdraw from this contract by an unequivocal statement (on example, a letter sent by post). You can use the model withdrawal form. To meet the deadline to withdraw from the contract, it is enough for you to send information regarding the exercise of your right to withdraw from the contract before the deadline to withdraw from the contract.

Effects of withdrawal from the contract.

In the event of withdrawal from this contract, we will refund all payments received from you, including the costs of delivery (except for additional costs, resulting from the delivery method chosen by you other than the cheapest usual delivery method offered by us. Shipping cost is not refunded for orders from outside the EU area), immediately, and in any case not later than 14 days from the day on which we were informed about your decision to exercise the right to withdraw from this contract. We will refund your payment using the same methods payments that you used in the original transaction, unless you have expressly agreed otherwise; in any case you will not incur any fees in connection with this refund. We may withhold reimbursement until we receive the item or until we receive proof of sending it back, whichever the event will happen sooner. Please send or return the item to us immediately, and in any case not later than 14 days from the day on which you informed us of the withdrawal from this agreement. The deadline is met if you send back the item within 14 days. You will have to bear the direct cost of returning the item. You are only responsible for reducing the value of things resulting from using it in a different way than it was necessary to establish the nature, characteristics and functioning of things.
